

## **SUUNTO 2009 ONLINE CALENDAR PHOTO COMPETITION INSTRUCTIONS AND COMPETITION RULES**

Participation in the competition requires full acceptance of the following rules:

### **1. Entry**

Suunto 2009 Online Calendar Photo Competition is valid between October 29<sup>th</sup>, 2008 and December 31<sup>st</sup>, 2008.

In order to participate to the competition, submit your competition entry together with your contact information to [competition@suunto.com](mailto:competition@suunto.com).

Final date for submitting entries is Wednesday December 31<sup>st</sup>, 2008, at 4 PM European GMT +2 (date and time of e-mail arrival constitutes proof).

### **2. Conditions for participating**

Participants aged 18 or under must obtain consent from their parent or guardian prior to entering the competition.

Employees of Amer Sports companies are not authorized to participate in this competition.

Only three images per person will be accepted.

In case your photo is chosen as one of the winning images, you should be able to deliver 2 MB or larger version of the specific image. Suunto will ask these larger versions of the photos separately from the winners.

### **3. Allocation for the winner**

The Suunto jury will select the winning photos by February 13<sup>th</sup>, 2009. Suunto will contact the winners personally by e-mail by end of February 2009 and publish their names and photos on its website by the end of 2009.

### **4. Prizes**

All the participants, whose photographs will be used in the Suunto Calendar 2009, will be awarded with Suunto product of their choice (worth 99-700 euros).

Prize is non-transferable and no cash alternative shall be offered. Arrangements for the fulfillment of prize will be made by Suunto. Suunto reserves the right, at Suunto's sole discretion, to substitute any and all prizes with prizes of comparable value.

All federal, state and local taxes, fees and surcharges on the prizes are the sole responsibility of the prize winners.

Photographers retain all copyrights to their submitted images. You warrant and undertake that your contribution is original and that you have full power to make the above authorization for using the materials. You sign for and accept responsibility for releasing this material on behalf of any and all co-authors/photographer/people in the photo.

## **6. Your responsibilities**

You agree not to submit any materials that infringe any intellectual property rights of any person (for example copyright or trademark rights).

When participating in the competition you also agree not to send any materials that are unlawful, harmful, insulting or otherwise objectionable; advertisements or other commercial materials abuse other people's privacy.

## **7. Other conditions**

Suunto will review the materials before posting them on its site or possible using them in its printed materials. Suunto reserves the right to edit or remove photos and other materials without notice at any time at its sole discretion.
